Cost of Acquisition	Hall cost £350,000 and bowls area £150,000
Present Use	Village hall, car park, bowls green, open space and play area with access road

**Coronation Playground**

Description	Large grassed area of approximately 1 acre with boundaries that include fencing, hedgerows and trees
Location	Land accessed from Wattisham Road
Owner/Custodian	Owner
Date of Acquisition	29 <sup>th</sup> April, 1955
Cost of Acquisition	No fee – donated to the Parish Council
Present Use	Playing field

**Grove Cemetery**

Description	Cemetery
Location	Land south of St Mary Magdalene's Church, Church Lane, Bildeston comprising consecrated and unconsecrated ground
Owner/Custodian	Owner
Date of Acquisition	1993
Cost of Acquisition	Not known
Present Use	Cemetery – established through planning consent on 25 <sup>th</sup> November, 1993 (formerly agricultural land)

**Kings' Pightle**

Description	Grassed area and natural habitat
Location	Land to the south-west of the B1115
Owner/Custodian	Custodian Trustee. Bildeston Parish Council transferred the land to a Management Committee – the Charity trustees - on 11 <sup>th</sup> June, 1997.
Date of Acquisition	18th July, 1994
Cost of Acquisition	Not known
Present Use	Nature reserve

## Market Place

Description	Surfaced area in the centre of the village
Location	Adjacent to the High Street
Owner/Custodian	Owner
Date of Acquisition	Not known
Cost of Acquisition	Not known
Present Use	Market place trading, clock tower, war memorial and residential parking as permitted by the Parish Council

## Sportsfield

Description	Large grassed area of approximately 6 acres with boundaries that include fencing, hedgerows and trees
Location	Land accessed from Consent Lane
Owner/Custodian	Custodian Trustee. Bildeston Parish Council transferred the land to a Management Committee - the Charity trustees on 5 <sup>th</sup> December, 1980. The Parish Council acts as Custodian trustee.
Date of Acquisition	26 <sup>th</sup> October, 1979 (subsequently transferred)
Cost of Acquisition	£10,000
Present Use	Playing field for sports and recreation
